GOVERNORS' REPORT

FOR THE YEAR ENDED 31 AUGUST 2022

The governors present their annual report together with the accounts and auditor's report of the charitable company for the year 1 September 2021 to 31 August 2022. The annual report serves the purposes of both a trustees' report, and a directors' report under company law.

The academy trust operates an academy for pupils aged 4 to 7. It has a pupil capacity of 270 and had a roll of 248 in the school census in January 2022.

Structure, governance and management

Constitution

The academy trust is a company limited by guarantee and an exempt charity. The charitable company's memorandum and articles of association are the primary governing documents of the academy trust.

The governors are the trustees of Joydens Wood Infant School and are also the directors of the charitable company for the purposes of company law. Details of the governors who served during the year are included in the Reference and Administrative Details on page 1.

Joydens Wood Infant School was incorporated on 10 October 2011 and obtained Academy status from 1 November 2011.

Members' liability

Each member of the charitable company undertakes to contribute to the assets of the charitable company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

Method of recruitment and appointment or election of governors

The members of the Academy Trust shall comprise the signatories to the Memorandum, 1 person appointed by the Secretary of State, in the event that the Secretary of State appoints a person for this purpose, the Chairman of the Governors and any person appointed under Article 16.

The number of Governors shall be not less than 3, but shall not be subject to a maximum. The first Governors shall be those named in the initial Memorandum. The Academy Trust shall have up to 11 Governors; 2 Staff Governors, a minimum of 2 parent Governors; the Headteacher, any Additional Governors if appointed under Article 62,62A or 68A; and any Further Governors if appointed under Article 63 or Article 68A. The Academy may also have up to 3 Co-opted Governors, a person who is appointed to be a Governor by being co-opted by Governors who have not themselves been so appointed. The Governors may not co-opt an employee of the Academy Trust as a Co-opted Governor if the number of Governors who are employed by the Academy Trust would thereby exceed one third of the total number of Governors (including the Headteacher).

Each of the persons entitled to appoint members above shall have the right, from time to time by written notice delivered to the Office, to remove any Member appointed by them and to appoint a replacement member to fill a vacancy whether resulting from such removal or otherwise.

The term of office for any Governor shall be 4 years, save that this time limit shall not apply to the Headteacher. Subject to remaining eligible to be a particular type of Governor, any Governor may be re-appointed or re-elected.

Policies and procedures adopted for the induction and training of governors

During the year under review the Governors held 3 Full Governing Body meetings and 3 Committee meetings. The training and induction provided for new Governors will depend on their existing experience. All new Governors will be given a tour of the Academy and the chance to meet with staff and students. All relevant Governors are provided with copies of policies, procedures, minutes, accounts, budgets, plans and other documents that they will need to undertake their role as Governors. As there are normally only two or three new Governors a year, induction tends to be done informally and is tailored specifically to the individual.

Organisational structure

Our Leadership Team consists of; Headteacher, Deputy Headteacher, Family Engagement Leader and School Business Managers. These leaders control the Academy at an executive level implementing the policies laid down by the Governors and reporting back to them. The Leadership Team ensure that the school moves rapidly forward in a strategic way enabling current forward thinking practice to be rapidly embedded and sustained across the school.

Our school consists of Senior Leaders, Middle Leaders, Teachers, Cover Supervisors and Learning Support Assistants and Catering/Admin Teams. Whole school CPD is based around statutory policies and procedures and weekly/termly CPD is based on staff's own professional development needs.

The Governors are responsible for setting general policy, adopting an annual plan and budget, monitoring the Academy by the use of budgets and making major decisions about the direction of the Academy, capital expenditure and senior staff appointments. Governance plays an important role in effective leadership as they consistently challenge leaders and hold staff to account on the decisions/progression within the school.

Arrangements for setting pay and remuneration of key management personnel

Rigorous and collaborative approach feeds into the pay progression for our team. Headteacher performance management is undertaken by the appointed Governors with the review in October each year. Other leadership posts are managed by the Headteacher who ensures that accountability and impact is equally measurable. Pay progression is linked to effective outcomes of staff and on their individual performance based on their level of responsibility. All performance management targets are set through professional discussion and progression towards these targets and are planned through targeted CPD.

Related parties and other connected charities and organisations

We share a site with Joydens Wood Junior School.

Objectives and activities

Objects and aims

Joydens Wood Infant School is a school with children aged 4 - 7. We foster a genuine sense of respect for the individual alongside an appreciation of the culture and beliefs of others.

The principal objective of the Academy is specifically restricted to the following, to advance the public benefit education in the United Kingdom, in particular but without prejudice to the generality of the foregoing by establishing, maintaining, carrying on, managing and developing a school offering a broad and balanced curriculum.

Objectives, strategies and activities

The main objectives of the Academy during the year ended 31 August 2022 are summarised below:

Leadership and Management:

- Enabling leaders to rapidly identify issues/next steps alongside patterns/trends in a data
- Pupil progress meetings are data driven and shared with parents, specifically with those that are most vulnerable (PP, SEN).

Teaching and Learning (Inc. EYFS):

- · Through cross curricular planning that encompasses crucial reading, writing and numeracy skills
- Through an experience based approach that effectively links to every subject PoSK.
- Teaching Assistants have a clear understanding of the differentiation and how implement this in action
- A shared 'language for learning' is evident across the school with adults actively using questioning to gain a deeper understanding of children's learning
- · Strategies for early reading and writing are consistent across the school from adult to adult

Attendance:

• Reduce the number of absences (authorised and unauthorised) and term time holidays (including a joint approach for shared families with JWJ).

Embed our new vision and values (created jointly with; governors, parents, children and staff):

Our Mission Statement is:

In our school we stimulate awe and wonder through a captivating curriculum that develops effort based on learning. We support and work together to make our school a purposeful place that enables every child to thrive and succeed. We celebrate differences and see the uniqueness in all.

A happy and safe place to learn and grow.

Our Values are:

- Ready: being on time for school, having excellent attendance and showing outstanding behaviour for learning
- Respectful: respecting others for who they are, regardless of our differences, being kind and helpful towards others and listening to each other and adults
- Responsible: being good role models, taking ownership of our learning, looking after our school and demonstrating kindness by helping others to do the same
- Resilient: taking on challenges by putting in lots of effort, striving to improve and recognising our own and others' achievements, no matter how big or small

Children will be happy and healthy, enthused by the intellectual, social and physical challenges posed by their experience at school. They will be independent learners, aware of how to learn and of the role of emotions and dispositions in the learning process, which they draw on to address challenge and difficulty, as well as success.

All staff will have the opportunity to develop further as self-directed, reflective learners, through working collaboratively with others to enhance their own expertise. Through their passion, teachers will enthuse and inspire others to explore new ideas.

Parents will fulfil their roles as true partners, recognizing their role in the child - school - parent partnership to ensure that their child realises his/her potential.

Governors will contribute to the life of the school on a wider scale, acting as critical friends to support the school in becoming a nationally recognised centre of excellence.

Public benefit

The Governors confirm that they have referred to the guidance contained in the Charity Commission's general guidance on Public Benefit when reviewing the charity's aim and objectives and in planning future activities. In particular, the trustees consider how planned activities will contribute to the aims and objectives they have set.

Reception admissions are administered by The Admissions and Transport Team, Kent County Council.

In the event of over-subscription, places will be offered in descending order to:

- · in Local Authority Care
- Current family association (A brother or sister in the same school at the time of entry where the family continue to live at the same address as when the sibling was admitted or if they have moved live within 2 miles of the school or have moved to a new property that is nearer to the school than the previous property).
- Health and Special Access reasons (Children who for reasons of health or physical impairment need to attend a particular school)
- · Children of teachers
- · Nearness of children's homes to school
- · Summer born children and admissions out of year group

Strategic report

Achievements and performance

The Academy currently has a falling roll of children.

2020-2021 roll was 255/270 2021-2022 roll was 248/270 2022-2023 roll was 239/270

Falling roll eludes to a range of factors; lack of housing/ affordable development in the area and prospective parents expressing views of wanting our school to be a through primary.

The school's academic results for KS1, Phonics Screening Check and EYFS were not recorded for the academic year 2019-2020 or 2020 - 2021 due to the Covid-19 pandemic.

Key performance indicators

The following aspects were set out to determine the effectiveness of the school's new curriculum design, however Covid-19 hindered the school's ability to demonstrate this in a contextual way:

- Number of persistent absentees is reduced to 7.6%, below Local Authority and National averages (Kent 9.7% & National 8.8%)
- The number of children absent from school has reduced to 2.5% from 5.1% in 2018/19 and is below Local Authority and National averages (Kent 3.8% & National 3.6%)
- 73.3% of children passing the Phonics Screening Test in Year 1, just below National and Local Authority averages (Kent 74.2% & National 75.5%)
- EYFS GLD is above National at 69%. The National average of children attaining this is 65.2% and in Kent it was 65.4%
- KS1 results remain below National.

These KPIs will be closely scrutinised throughout academic year 2022-2023 and strategic priorities have been set in targeted areas to further enhance the quality of education at Joydens Wood Infant School and improve KS1 and Phonics results.

GOVERNORS' REPORT (CONTINUED)

FOR THE YEAR ENDED 31 AUGUST 2022

Going concern

After making appropriate enquiries, the governing body has a reasonable expectation that the academy trust has adequate resources to continue in operational existence for the foreseeable future. For this reason it continues to adopt the going concern basis in preparing the financial statements. The Governing Body are reviewing the reserves position closely and their analysis is detailed below:

Budget position:

Budget forecasts for next year shows a negative in year position but due to a health rollover from 202-21 with a potential deficit carried forward at the end of Year 3. Additional changes detailed below, once applied, the expectation is there will be no overall deficit in year 3.

Increased income:

Expectation of small percentage increase in funding per pupil for 2022-23 and 2023-24 despite reduction in pupil numbers.

Increase in lettings and caterings income due to price rises. Donations and fundraising as well as High Needs funding to increase.

Reduced Expenditure:

Fixed term non-teaching staffing vacancy not to be renewed after September 2023. Potential move to reduce number of classes as a result of expected reduction in pupil numbers.

Site Manager to be recruited in 2022/23 with costs split with neighbouring Junior school. Reduction on catering expenditure to match income from UIFSM

Positive cashflow position expected over next 12 months, large payments to creditors included in final accounts spread over next financial year.

The above budget position details may be impacted by the impending move of Joydens Wood Infant School into the NEXUS academy trust, which is due to occur before 31 August 2023.

Further details regarding the adoption of the going concern basis can be found in the Statement of Accounting Policies.

Financial review

Most of the Academy's income is obtained from the Education and Skills Funding Agency (ESFA) in the form of recurrent grants, some of which are restricted to particular purposes. The grants received from the ESFA during the year ended 31 August 2022 and the associated expenditure are shown as restricted funds in the Statement of Financial Activities.

GOVERNORS' REPORT (CONTINUED)

FOR THE YEAR ENDED 31 AUGUST 2022

The Academy also receives grants for fixed assets from the ESFA. In accordance with the Charities Statement of Recommended Practice, 'Accounting and Reporting by Charities' (SORP 2015), such grants are shown in the Statement of Financial Activities as restricted income in the fixed asset fund. The restricted fixed asset fund balance is reduced by annual depreciation charges over the expected useful life of the assets concerned.

During the year ended 31 August 2022, total expenditure of £1,427k (2021: £1,290k) was met by recurrent grant funding from the ESFA together with other incoming resources. The excess of expenditure over income for the year (excluding restricted fixed asset funds and transfers to restricted fixed asset funds) was £60k (2021:£2k income over expenditure).

Additional funding streams not in budget such as National Insurance increases from April 2022 and additional High Needs pupils helped increase income.

School was able to run profitable fundraising events which increased income significantly compared to budget.

Reduction in hours of senior staff members as well as using existing staff to cover short term absences helped to make savings on staffing expenditure, as well as tight control of other non-staffing costs throughout the year.

Principal risks moving forward are the potential for pupil numbers to reduce over the next few years as well as the removal of Universal Infant Free School Meal (UIFSM) funding.

Plans are in place to encourage prospective parents to apply for places and contingency plans have been considered in the event that UIFSM funding is withdrawn.

Key factors affecting the trusts financial performance are:

- Pupil number fluctuation
- · Increased staffing costs
- · Removal of key funding streams
- · Increased non-staffing costs due to potential for supplier costs to go up due to inflation

At 31 August 2022 the net book value of fixed assets was £2,399k (2021: £2,182k). Movements in tangible fixed assets are shown in note 11 to the financial statements. The assets were used exclusively for providing education and the associated support services to the pupils of the Academy.

The Kent County Council Pension Fund, in which the Academy participates, showed a deficit of £131k at 31 August 2022 (2021: £875k).

The Academy held fund balances at 31 August 2022 of £2,388k (2021: £1,361k) comprising £2,330k (2021: £1,322k) of restricted funds and £58k (2021: £39k) of unrestricted general funds. Restricted funds are represented by £2,399k (2021: £2,182k) of tangible fixed assets, £7k of unspent capital funding (2021: £nil), £64k of unspent GAG (2021:£37k), nil (2021:£13k) of unspent COVID funding, less amounts due to Kent County Council for a pension recharge of nil (2021: £24k) and £9k (2021: £6k) due to Salix.

The pension reserve, which is considered part of restricted funds, was £131k (2021: £875k) in deficit.

Reserves policy

The Governors review the reserve levels of the Academy annually. This review encompasses the nature of income and expenditure streams, the need to match income with commitments and the nature of reserves. The Governors have determined that the appropriate level of free reserves should be equivalent to four weeks' expenditure, approximately £95k (2021: £88k).

The academy's current level of free reserves is £58k (2021: £39k) (total funds less the amount held in fixed assets and restricted funds). The Trustees are aware that reserves have fallen below policy and are looking at approaches to increase reserves in future periods.

GOVERNORS' REPORT (CONTINUED)

FOR THE YEAR ENDED 31 AUGUST 2022

Investment policy

Under the Memorandum and Articles of Association, the Academy has the power to invest funds not immediately required for its own purposes, in any way the Governors see fit. The organisation has a positive cash balance to cover eventualities and unforeseen expenses. The banking facilities are reviewed on a regular basis.

Principal risks and uncertainties

The Governors consider the following to be the major risks to which the Academy is exposed:

The principal financial risk faced by the school is the ongoing pressure on funding resulting in a risk that a deficit may be experienced. Pupil numbers are stringently monitored, but cannot be forecast accurately for the Reception intake. The budgeting and reporting process, including scrutiny by the Governors, mitigates the risk.

The risk that Trustees do not ensure that rigorous monitoring is undertaken in the absence of the Headteacher and/ or Business Manager. Kent Financial Services can be contracted to perform monthly monitoring if required which is then scrutinised by Governors.

The Governors have implemented a number of systems to assess risks that the school faces, especially in the operational areas (e.g. in relation to teaching, health and safety, bullying and school trips) and in relation to the control of finance. The Governors are introducing systems, including operational procedures and internal financial controls in order to minimise risk. Where significant financial risk still remains they have ensured they have adequate insurance cover. The Academy has an effective system of internal financial controls and this is explained in more detail in the Governance Statement on pages 10 to 14.

COVID-19

As a result of the global pandemic, there has been an additional impact on both income and expenditure experienced by Joydens Wood Infant School.

Additional expenditure has been required to cover extra cleaning covered by both contract cleaners as well as the staff, which has had an impact on both time and reserves. This continued in 2021-22 but these additional costs have not been recoverable from additional grants as they were in 2019-20.

Extra funding was received in 2021-22 as part of the Governments catch-up funding which is being used to provide additional support and resources as part of the COVID catch-up strategy. This is expected to continue in 2022-23.

In addition to this, income from lettings for the year ending 31 August 2022 was increased as a result of the removal of restrictions applied as a result of the pandemic

The principal risks and uncertainties that Joydens Wood Infant School faces are mitigated by the risk management process that the academy trust has in place.

Financial and risk management objectives and policies

The main financial risks which Joydens Wood Infant School is exposed, taking account of the mitigations in place, relate the risk of an income shortfall due to the likelihood of further government spending reductions affecting our general grant.

A risk also arises in relation to the defined benefit pension scheme, due to the fact that there is a deficit of £131k (2021: £875k). The school follows the advice of the scheme's actuaries, specifically as regards the level of contributions payable, ensuring that annual budgets are drawn up to reflect the actuary's advice.

Fundraising

The academy trust does not use any external fundraisers. All fundraising during the year was monitored by the trustees.

GOVERNORS' REPORT (CONTINUED)

FOR THE YEAR ENDED 31 AUGUST 2022

Plans for future periods

Since the last inspection all Middle Leader posts have changed personnel. All current Middle Leaders are involved in the curriculum design and development. A new JWI curriculum has been created. Middle Leaders have detailed knowledge of how children learn and how to sequence the curriculum over time. The whole school curriculum is based on an even mix of fluency and conceptual understanding with a strong emphasis on Early Literacy and Mathematics. The school adopts a child led approach across school with the complexity and implementation changing as the learning progresses through the year groups.

The school has a streamlined structure with our middle leaders, all staff having structured monitoring guidance and expectations. This is to support them to be clear in what is expected from them. Middle Leaders attend external sources of expertise and CPD. They attend regular cross school sessions to raise awareness and improve practices. Our Middle Leaders proactively seek collaborative opportunities to develop their expertise and knowledge.

Wholes School Priorities for 2021/2022:

- Leaders to continue enhancing teachers pedagogical content knowledge in relation to the new JW Curriculum
- Governors need to confidently hold Leaders to account for the impact of the new JW Curriculum and new SPP.
- Leaders need to confidently lead Pupil Progress Meetings and ensure academic barriers to learning are linked directly to the new JW Curriculum.
- Teachers to plan regular teaching and learning forums for 'pre-teaching' parents concepts using the new JW Curriculum

Key Priorities 2022-2023

- Love of reading is threaded through all aspects of school life and is modelled by all staff and governors.
- Ensure the new SSP is impactful to ensure high phonic outcomes that support reading and writing progress.
- Leaders (Inc. governors) work collaboratively to roll out the new curriculum and embed enquiry-led learning in KS1.
- Governors need to be secure in their understanding of the impact of the new JW Curriculum to be able to hold leaders to account in the quality of education.

Identified by Ofsted upon the school's last report (2018).

- Leaders and those responsible for governance should ensure that: Pupils' attendance improves, overall and for disadvantages pupils
- Leadership and management improved by developing middle and subject leaders' effectiveness in developing teaching and the curriculum.

The above plans may be impacted by the impending move of Joydens Wood Infant School into the NEXUS academy trust, which is due to occur before 31 August 2023.

Scope of responsibility

As governors, we acknowledge we have overall responsibility for ensuring that Joydens Wood Infant School has an effective and appropriate system of control, financial and otherwise. However, such a system is designed to manage rather than eliminate the risk of failure to achieve business objectives, and can provide only reasonable and not absolute assurance against material misstatement or loss.

The board of governors has delegated the day-to-day responsibility to the Headteacher, as accounting officer, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the funding agreement between Joydens Wood Infant School and the Secretary of State for Education. The accounting officer is also responsible for reporting to the board of governors any material weaknesses or breakdowns in internal control.

Governance

The information on governance included here supplements that described in the Governors' Report and in the Statement of Governors' Responsibilities. The board of governors has formally met 3 times during the year. Due to the small size of the Trust, this frequency of formal meetings has been adequate; additional ad-hoc meetings are convened when required and smaller working groups are set up for specific tasks as necessary. The board's performance is reviewed annually via a Governing Body effectiveness assessment which includes analysis of effective accountability as well as a skills audit.

5 Governors were added to the Governing body in the 2021-22 financial year. This included 2 appointed Governors who were added due to the skills they were able to identify as part of a Parent Governor election that took place in September 2021. These skills were deemed to be desirable due to gaps identified via a skills audit of the Governing Body.

The governing body continues to act effectively and diligently in fulfilling its 3 core functions:

- Ensuring clarify of vision and strategic direction
- · Holding the Headteacher to account for the performance of pupils and staff
- Ensuring financial probity

Joydens Wood Infant School hold six meetings a year which all governors are invited to. Three are classified as Full Governing Body meetings and three as sub-committee meetings.

The major challenge to the school remains the current funding crisis. A falling roll and increased staffing costs have made it difficult to avoid setting an overall deficit budget. This has been achieved for the current year with the help of a health rollover from 2020-21 but future budget plans will become more critical without increased government funding.

The Governing body undertook an annual self evaluation review including a development plan for year ending 31 August 2022

Conflicts of interest

The Governing body require all members to complete a declaration of business interests to help identify any potential conflicts of interest.

When conflicts of interest are identified with a particular trustee, the Governing Body will exclude the individual from that part of the meeting whilst the issue is being discussed. Any decisions made will then be voted for excluding the affected Trustee in order that they cannot have any undue influence as a result of the conflict of interest.

The Resources & Audit Committee and School Improvement & Safeguarding Committee are sub-committees of the main board of governors. The meetings are held in tandem and they formally met 3 times during the year.

Review of value for money

The purpose of the system of internal control

The system of internal control is designed to manage risk to a reasonable level rather than to eliminate all risk of failure to achieve policies, aims and objectives. It can therefore only provide reasonable and not absolute assurance of effectiveness. The system of internal control is based on an on-going process designed to identify and prioritise the risks to the achievement of academy trust policies, aims and objectives, to evaluate the likelihood of those risks being realised and the impact should they be realised, and to manage them efficiently, effectively and economically. The system of internal control has been in place in Joydens Wood Infant School for the period 1 September 2021 to 31 August 2022 and up to the date of approval of the annual report and accounts.

Capacity to handle risk

The board of governors has reviewed the key risks to which the academy trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks. The board of governors is of the view that there is a formal ongoing process for identifying, evaluating and managing the academy trust's significant risks that has been in place for the period 1 September 2021 to 31 August 2022 and up to the date of approval of the annual report and accounts. This process is regularly reviewed by the board of governors.

The risk and control framework

The academy trust's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the board of governors;
- regular reviews by the Resources Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes;
- setting targets to measure financial and other performance;
- clearly defined purchasing (asset purchase or capital investment) guidelines;
- identification and management of risks.

The Governing Body has considered the need for a specific internal audit function and has decided not to appoint a Responsible Officer. However, the Governors have appointed Kent County Council Internal Audit Service (KCCIAS) to complete the internal audit function. KCCIAS's role includes giving advice on financial matters and performing a range of checks on the Academy Trust's financial systems.

In particular the checks carried out in the current period include:

- Testing of Governance control procedures
- Testing of Payroll and HR functions
- Testing of Purchase Card control procedures•
- Testing of Income and Banking control procedures
- Testing of Contracts and Procurements functions
- Testing of Management Accounts functions

The Governing body also reviews Safeguarding as regular agenda items at both Committee and Full Governing Body meetings. Additional items linked to the risk register are also reviewed and discussed with strategic actions included in the minutes.

KCCIAS reports to the Governing body on the operation of the systems of control and on the discharge of the Governing Body's financial responsibilities.

Review of effectiveness

As accounting officer the Headteacher has responsibility for reviewing the effectiveness of the system of internal control. During the year in question the review has been informed by:

Opinion

### NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 AUGUST 2022

### 1 Accounting policies

Joydens Wood Infant School is a charitable company. The address of its principal place of business is given on page 1 and the nature of its operations are set out in the governors' report.

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgements and key sources of estimation uncertainty, is set out below.

### 1.1 Basis of preparation

The accounts of the academy trust, which is a public benefit entity under FRS 102, have been prepared under the historical cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2021 to 2022 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

### 1.2 Changes in accounting policies

Previously leasehold land had not been depreciated, however as the Academy has the right to use over the course of the lease the Trustees have made the decision to depreciate the land over the 125 years of the lease.

### 1.3 Going concern

The governors assess whether the use of going concern is appropriate, ie whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the charitable company to continue as a going concern.

It is expected that the academy will join NEXUS Educational Schools Trust before 31 August 2023 and on that date all of its assets, liabilities and activities will be transferred. From that date it is likely that the legal entity known as Joydens Wood Infant School will cease to exist and for this reason the Trustees consider the academy trust is no longer a going concern. The accounts have therefore been prepared on the basis that the Academy Trust is not a going concern.

### 1.4 Income

All incoming resources are recognised when the academy trust has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

### Grants

Grants are included in the statement of financial activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the balance sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the statement of financial activities in the period for which it is receivable, and any abatement in respect of the period is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the balance sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

### **Donations**

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

# NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2022

### 1 Accounting policies

(Continued)

### Other income

Other income, including the hire of facilities, is recognised in the period it is receivable and to the extent the academy trust has provided the goods or services.

### Donated goods, facilities and services

The value of donated services and gifts in kind provided to the academy trust are recognised at their open market value in the period in which they are receivable as incoming resources, where the benefit to the academy trust can be reliably measured. An equivalent amount is included as expenditure under the relevant heading in the statement of financial activities, except where the gift in kind was a fixed asset in which case the amount is included in the appropriate fixed asset category and depreciated over the useful economic life in accordance with the academy trust's policies.

#### Donated fixed assets

Donated fixed assets are measured at fair value unless it is impractical to measure this reliably, in which case the cost of the item to the donor is used. The gain is recognised as income from donations and a corresponding amount is included in the appropriate fixed asset category and depreciated over the useful economic life in accordance with the academy trust's accounting policies.

#### Interest receivable

Interest receivable is included within the statement of financial activities on a receivable basis.

### 1.5 Expenditure

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement, and the amount of the obligation can be measured reliably.

Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges are allocated on the portion of the asset's use.

All resources expended are inclusive of irrecoverable VAT.

### Expenditure on raising funds

This includes all expenditure incurred by the academy trust to raise funds for its charitable purposes and includes costs of all fundraising activities events and non-charitable trading.

### Charitable activities

These are costs incurred on the academy trust's educational operations, including support costs and costs relating to the governance of the academy trust apportioned to charitable activities.

### Governance costs

These include the costs attributable to the academy trust's compliance with constitutional and statutory requirements, including audit, strategic management, governors' meetings and reimbursed expenses.

# NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2022

### 1 Accounting policies

(Continued)

### 1.6 Tangible fixed assets and depreciation

Individual assets costing £1,000 or more and groups of assets costing £3,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the balance sheet at cost and depreciated over their expected useful economic life. The related grants are credited to a restricted fixed asset fund in the statement of financial activities and carried forward in the balance sheet. Depreciation on such assets is charged to the restricted fixed asset fund in the statement of financial activities so as to reduce the fund over the useful economic life of the related asset on a basis consistent with the academy trust's depreciation policy. Where tangible fixed assets have been acquired with unrestricted funds the cost is transferred to the restricted fixed asset fund, depreciation on such assets is charged to the restricted fixed asset fund.

The property has been included at the valuation provided by the ESFA when completing their desktop valuation.

The academy has a 125 year lease from conversion on the land and buildings with Kent County Council.

Depreciation is provided on all tangible fixed assets other than freehold land, at rates calculated to write off the cost of each asset on a straight-line basis over its expected useful life, as follows:

Leasehold buildings50 YearsLeasehold land125 yearsLeasehold improvements20 yearsComputer equipment3 yearsFixtures, fittings & equipment4 Years

Assets in the course of construction are included at cost. Depreciation on these assets is not charged until they are brought into use and reclassified to freehold or leasehold land and buildings.

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the statement of financial activities.

### 1.7 Liabilities

Liabilities are recognised when there is an obligation at the balance sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the academy trust anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods of services it must provide.

### 1.8 Leased assets

Rentals under operating leases are charged on a straight-line basis over the lease term.

### 1.9 Financial instruments

The academy trust only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the academy trust and their measurement basis are as follows.

### Financial assets

Trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost. Prepayments are not financial instruments.

Cash at bank is classified as a basic financial instrument and is measured at face value.

### Financial liabilities

Trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost. Taxation and social security are not included in the financial instruments disclosure definition.

Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument.

#### 1.10 Taxation

The academy trust is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly, the academy trust is potentially exempt from taxation in respect of income or capital gains received within categories covered by chapter 3 part 11 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

### 1.11 Pensions benefits

Retirement benefits to employees of the academy trust are provided by the Teachers' Pension Scheme ('TPS') and the Local Government Pension Scheme ('LGPS'). These are defined benefit schemes and the assets are held separately from those of the academy trust.

The TPS is an unfunded scheme and contributions are calculated to spread the cost of pensions over employees' working lives with the academy trust in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary based on quadrennial valuations using a prospective unit credit method. The TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions are recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the academy trust in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each balance sheet date. The latest actuarial valuation of the LGPS was carried out on 31 March 2019. The amounts charged to net income or expenditure are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the statement of financial activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses. Actuarial gains and losses are recognised immediately in other recognised gains and losses.

### 1.12 Fund accounting

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the academy trust at the discretion of the governors.

# NOTES TO THE FINANCIAL STATEMENTS (CONTINUED) FOR THE YEAR ENDED 31 AUGUST 2022

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the Education and Skills Funding Agency and Department for Education where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received and include grants from the Education and Skills Funding Agency and Department for Education.

### 2 Critical accounting estimates and areas of judgement

Accounting estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

### Critical accounting estimates and assumptions

The academy trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 18, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2022. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

### Critical areas of judgement

Useful economic lives of tangible assets

The annual depreciation charge for tangible assets is sensitive to changes in the estimated useful economic lives and residual values of the assets. The useful economic lives and residual values are re-assessed annually. They are amended when necessary to reflect current estimates, based on technological advancement, future investments, economic utilisation and the physical condition of the assets. See 11 for the carrying amount of the property plant and equipment, and note 1.5 for the useful economic lives for each class of assets.

There are no key assumptions concerning the future and other key sources of estimation uncertainty at the reporting date that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

The land was initially transferred on the 1 November 2011 and therefore a prior year adjustment has made to reflect the correct bought forward depreciation, amounting to £30k and to include the depreciation charge for last year amounting to £3k. The net affect is to reduce the net book value of leasehold land and buildings by £33K as at 31 August 2021.

### 18 Pension and similar obligations

The academy trust's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Kent County Council. Both are defined-benefit schemes.

The pension costs are assessed in accordance with the advice of independent qualified actuaries. The latest actuarial valuation of the TPS related to the period ended 31 March 2016 and of the LGPS 31 March 2019.

Contributions amounting to nil (2021: nil) were payable to the schemes at 31 August 2022 and are included within creditors.

#### **Teachers' Pension Scheme**

### Introduction

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for teachers in academies. All teachers have the option to opt out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary. These contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

### Valuation of the Teachers' Pension Scheme

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019.

The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% employer administration charge)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million, and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI. The assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to the TPS in the period amounted to £99k (2021: £94k).

A copy of the valuation report and supporting documentation is on the Teachers' Pensions website.

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The academy trust has accounted for its contributions to the scheme as if it were a defined contribution scheme. The academy trust has set out above the information available on the scheme.

### **Local Government Pension Scheme**

The LGPS is a funded defined-benefit scheme, with the assets held in separate trustee-administered funds. The total contributions are as noted below. The agreed contribution rates for future years are 22.5% for employers and 5.5 to 12.5% for employees. The estimated value of employer contributions for the forthcoming year is £80k (2021: £68k).

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.

#### 23 Related party transactions

Owing to the nature of the Academy's operations and the composition of the Board of Governors being drawn from local public and private sector organisations, it is inevitable that transactions will take place with organisations in which a member of the Board of Governors may have an interest. All transactions involving such organisations are conducted at arm's length and in accordance with the Academy's financial regulations and normal procurement procedures.

Crundwell Creative is a company controlled by Scott Crundwell, the brother-in-law of Rachel Hately. Joydens Wood Infant School pay an annual website maintenance of £1,338 (2021: £1,260). The academy trust made the purchase at arms' length and Rachel Hately was not involved in the decision to appoint Crundwell Creative. In entering into the transaction, the academy trust has complied with the requirements of the Academies Financial Handbook.

The husband of E A Blake was employed as a premises manager until February 2022. Mr Blake's appointment was made in open competition and Mrs E Blake was not involved in the decision-making process regarding appointment. Mr Blake was paid within the normal salary scale for his role and received no special treatment as a result of his relationship to a Trustee.

### 24 Members' liability

Each member of the charitable company undertakes to contribute to the assets of the company in the event of it being wound up while he or she is a member, or within one year after he or she ceases to be a member, such amount as may be required, not exceeding £10 for the debts and liabilities contracted before he or she ceases to be a member.

### Notes to restatement

### i) Change in accounting policy on depreciation of leasehold land

Previously leasehold land had not been depreciated, however as the Academy has the right to use over the course of the lease the Trustees have made the decision to depreciate the land over the 125 years of the lease. The land was initially transferred on the 1 November 2011 and therefore a prior year adjustment has been made to reflect the correct bought forward depreciation, amounting to £30k and to include the depreciation charge for last year amounting to £3k.
